CREDIT TERMS AND PROCEDURES

Payments are due upon receipt of the statement. A finance charge will be added at the rate of 2% per month (24% APR) on balances not paid within 30 days.

GNH Lumber, Inc. reserves the right to put a hold on any account that is 60 days overdue or over the credit limit. If it is over 60 days two times, it will not be re-opened when paid. IN the event your account goes beyond 60 days, the following will go into effect:

75 days: any account not paid in full or making the “agreed upon” satisfactory payments will be turned over to a collection agency, credit bureau and subject to a mechanic’s lien.

Over 90 Days: Subject to further legal action customer will be responsible for any court fee’s sheriff’s fees, reasonable collection charges and/or attorney fees.

Drop Deliveries: You hereby permit and authorize GNH Lumber, Inc. (it’s agents or employees) to make drop deliveries at the delivery site designated in your order without first obtaining the signature of an authorized person. The occasion may arise that you are not on site to sign for said delivery, in such case you waive any defense that you may have in respect to loss of theft of delivered items, unless you can
